

## **Health Screening Questionnaire**

ALL DOE employees, visitors, and families must complete a health screening before entering DOE facilities. This health screening must be completed on each day of arrival. This health screening can also be completed online at: <a href="https://healthscreening.schools.nyc/">https://healthscreening.schools.nyc/</a>. Upon entering the facility, if you have not completed the online health form you will be asked to provide responses to the questions below.

1.	•	ou experienced any symptoms of COVID-19, including a fever of 100.0 degrees F or greater, a new cough, as of taste or smell or shortness of breath that started in the past 10 days?  No. Go to the next question.  Yes, and I have received a lab-confirmed negative result from a COVID-19 diagnostic test (not a blood test) since the onset of symptoms AND have not had symptoms for at least 24 hours. Go to the next
		question.  Yes, and I am not in the category above. No further screening is needed. The employee/guest may not enter the building.
2.	In the past 10 days, have you gotten a lab-confirmed positive result from a COVID-19 diagnostic test (not a blood test) that was your first positive result OR was AFTER 90 days from your previous diagnosis date?¹ Pleas note that 10 days is measured from the day you were tested, not from the day when you got the test result.  □ No. Go to the next question. □ Yes. No further screening is needed. The employee/guest may not enter the building.	
3.	three n interna weeks	a considered fully vaccinated against COVID-19 by CDC guidelines OR were you recently (within the past nonths) diagnosed with COVID-19 and finished isolation in the past 90 days <sup>2</sup> AND you have not traveled tionally in the past 10 days? Please note that to be considered fully vaccinated by CDC guidelines, two must have passed since you received the second dose in a two-dose series or two weeks must have since you received a single-dose vaccine. <sup>3</sup> No, I am not considered fully vaccinated. Go to the next question.  No, I am considered fully vaccinated or was diagnosed with COVID-19 in the past 90 days BUT I have traveled internationally in the past 10 days. The employee/guest can skip question 4 and must answer question 5.  Yes. The employee/guest does not need to answer questions 4 and 5 and may enter the building.

<sup>&</sup>lt;sup>3</sup> Until CDC has additional data from vaccine trials, NYS DOH has stated that anyone who has been fully vaccinated will have up to 90 days where they would be exempt from quarantine if exposed or traveled domestically. This 90 day cap may be extended as more vaccine trial data becomes available.

		Yes, I travelled domestically and was out of state for less than 24 hours, and I took or will take a COVID-19 test on the 4th day after my arrival in New York. The employee/guest may enter the building.	
		Yes, I was out of state for more than 24 hours and am returning from domestic travel from a non-contiguous state. I took a COVID-19 test within 72 hours PRIOR to my arrival in New York, quarantined for at least three days upon my arrival in New York, and took a second COVID-19 test on the 4th day AFTER my arrival, and got negative results on both tests OR I have completed a 10 day quarantine. The employee/guest may enter the building.	
		Yes, I was out of state for more than 24 hours and am returning from international travel. I have completed a 7 day quarantine and took a COVID-19 test 3 to 5 days after my arrival in New York and got a negative result on both tests OR I have completed a 10 day quarantine. The employee/guest may enter the building.	
		Yes, and I am not in the two categories above. The employee/guest may not enter the building.
